## Tax Sales and Tax Re-Sales Auctions:

- Tax Sales/Re-Sales are *generally* held quarterly and are always on the first Tuesday of the specified month at the bottom of this page.
- The list for the upcoming Tax Sales/Re-Sales will be available online at <a href="www.mvbalaw.com">www.mvbalaw.com</a> approximately 2-3 weeks before the sale.
- All sales are published in The Port Lavaca Wave newspaper three consecutive weeks before the sale.
- Any and all research or information not found on the list must be obtained by the purchaser. We strongly suggest that you view the GENERAL INFORMATION page found at <a href="https://www.mvbalaw.com">www.mvbalaw.com</a>.

## **Over the Counter Purchases - Trust Property:**

- You may purchase these properties by <u>paying whichever is less</u>: the total of all taxes, court costs and any other adjudicated amounts <u>OR</u> the market value. You should obtain estimated totals using the helpful links shown below. These amounts <u>MUST</u> be verified by our office the day payment is rendered.
- Any and all research, totals, or information not found on the list must be obtained by the purchaser. We strongly suggest you view the <u>GENERAL INFORMATION</u> page found at <u>www.mvbalaw.com</u>.

The forms of payment accepted are as follows- cash, cashier's check or money order. NO CARDS OF ANY KIND WILL BE ACCEPTED. Please have funds made payable to Calhoun County Sheriff's Office

After the sale has ended, the buyer has approximately two (2) hours to make payment in full.

If you intend to bid for a corporation, business or for someone other than yourself, you MUST provide proper notarized documentation stating that you have permission to do so.
