




Dear Secretary Nelson:

Pursuant to his powers as Governor of the State of Texas, Greg Abbott has issued the following:

A proclamation amending and renewing the disaster proclamation issued on April 27, 2026, certifying that the severe storm event that began on April 24, 2026, is causing widespread and severe property damage, injury, or loss of life in Calhoun, Lamar, Palo Pinto, Parker, Victoria, and Wise Counties, and declaring a disaster.

The original proclamation is attached to this letter of transmittal.

PROCLAMATION
BY THE
Governor of the State of Texas

TO ALL TO WHOM THESE PRESENTS SHALL COME:

WHEREAS, I, GREG ABBOTT, Governor of the State of Texas, issued a disaster proclamation on April 27, 2026, as amended and renewed in a subsequent proclamation, certifying that the severe storms event that began on April 24, 2026, which included heavy rainfall, flash flooding, hazardous wind gusts, large hail, and tornadoes, is causing widespread and severe property damage, injury, or loss of life in several counties;

NOW, THEREFORE, in accordance with the authority vested in me by Section 418.014 of the Texas Government Code, I do hereby amend and renew the aforementioned proclamation and declare a disaster in Calhoun, Lamar, Palo Pinto, Parker, Victoria, and Wise Counties.

Pursuant to Section 418.017 of the Texas Government Code, I authorize the use of all available resources of state government and of political subdivisions that are reasonably necessary to cope with this disaster.

Pursuant to Section 418.016 of the Texas Government Code, any regulatory statute prescribing the procedures for conduct of state business or any order or rule of a state agency that would in any way prevent, hinder, or delay necessary action in coping with this disaster shall be suspended upon written approval of the Office of the Governor. However, to the extent that the enforcement of any state statute or administrative rule regarding contracting or procurement would impede any state agency's emergency response that is necessary to protect life or property threatened by this declared disaster, I hereby authorize the suspension of such statutes and rules for the duration of this declared disaster.

In accordance with the statutory requirements, copies of this proclamation shall be filed with the applicable authorities.
